ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Kennewick School District No. 17 from September 1, 2009 through August 31, 2010.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Small and attractive assets
- Open public meetings/records laws
- Procurement (bidding/prevaling wage)
- Associated Student Body
- Alternative Learning Experience
- Payroll/personnel
- Apportionment – transportation reporting
- Financial condition
- Student store
- Revenue and expenditure trends

RESULTS

In most areas, the District complied with state laws and regulations and its own policies and procedures.

However, we noted certain matters that we communicated to District management. We appreciate the District's commitment to resolving those matters.

ABOUT THE DISTRICT

Kennewick School District No. 17, located in Benton County, provides educational services to approximately 15,000 students in pre-kindergarten through 12th grade. The District encompasses 292 square miles including the city of Kennewick and the unincorporated community of Plymouth. The District operates three high schools, an alternative high school, one project based high school, a skill center, four middle schools, 13 elementary schools and one preschool. In addition, the District also holds classes at the Juvenile Justice Center. An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 1,750 employees. For fiscal year 2009, the District operated on a \$194 million annual budget.

We audit the District on an annual basis. The past six audits of the District have reported one finding. The 2007 audit contained a finding related to transportation reporting. The District is continuing to resolve reporting of transportation routes.
